

WHERE WE ARE NOW

As I reflect on the last year, I am humbled by the impact our work had on children in foster care in Clackamas County, despite challenges faced as a result of the pandemic. The commitment from our Court Appointed Special Advocate (CASA) volunteers was even more important as pandemic restrictions led to increased isolation and online school. Our dedicated CASAs volunteered 14,794 total hours, providing advocacy for 438 children.

There are so many stories of the way that CASAs make an impact on children's lives that it's hard to narrow it down to one example. This story illustrates just one way CASAs provide support and ensure that the best interests of the children are at the forefront of all decisions made:

During the pandemic, a child in foster care was falling far behind due to virtual schooling, and so the resource parent offered to homeschool them one-on-one to catch them up to grade level. It is clear that they need this help. The child's father put up a huge fight about it and objected to the best interests motion to change the child's school to homeschooling.



They were concerned, and did not trust the resource parent's ability to teach the child.

The CASA stepped in and gathered lots of information about homeschooling in Oregon, information about the resource parent's credentials, put it all together and sent it to all parties. As a result of the information the CASA provided, the objection to the motion was withdrawn and this child can start getting caught up - and has - right away!

As retirement nears, and my time as Executive Director of CASA of Clackamas County comes to an end, I am filled with gratitude for our community. Together we are changing the lives of children in foster care in Clackamas County. Thank you for the role you play in this important work.

WITH OUR PARTNERS WE...

CASA of Clackamas County believes in working with our partners to help provide essential services and support to children in Clackamas County. Our collective impact led to many great successes this year, including:

GOVERNOR'S PROCLAMATION

With the help of Oregon CASA Network and lobbying partners, Governor Kate Brown declared May 18th CASA Volunteer Day. This proclamation will help shed light and appreciation on CASAs volunteers in May, which is also Foster Care Awareness Month!

HOUSE BILL 2738

Passed with the help of our partners, HB 2738 invests \$5.92 million to improve CASA operations, increase outreach, train new volunteers, support more neglected and abused children and create a statewide distance training and learning program for CASA volunteers, which will strengthen training efforts and provide flexibility beyond the COVID-19 pandemic.

SAFE KIDS COALITION FOR CLACKAMAS COUNTY

The Safe Kids Coalition for Clackamas County uses a collective impact model to ensure critical services are accessible to children and youth impacted by trauma. Their vision is to create a community where the safety and well-being of children and youth are a top priority and a shared responsibility.

Q. WHAT IS A CASA?

A. CASA stands for Court Appointed Special Advocate, a special kind of volunteer. When a child is placed in foster care, their CASA visits them, advocates for the child's needs, provides a voice in court for the child, and is a consistent, caring adult throughout their time in foster care.


Q. WHAT DOES A CASA DO?

A. A CASA volunteer visits with the child for whom they are advocating, getting to know the child. They gather information about the child, contact caseworkers, talk with parents and other family members, ensure the child receives necessary medical care, look out for educational needs, monitor the progress of the case, and make recommendations to the court regarding the permanent placement of the child. A CASA is a constant, consistent person during a very tumultuous time in the child's life.

Q. WHAT IS THE TIME COMMITTMENT?

A. We ask for a 2 year commitment. A CASA volunteer typically dedicates 10-20 hours per month to their case. After completing training, the CASA visits the child face to face at least once per month. CASAs also attend court hearings and other case meetings.






