When a child is removed from an abusive or neglectful environment and placed in foster care, it is important to have someone speaking up for the best interests of that child. CASA of Clackamas County is a non-profit organization dedicated to providing that advocacy for children who have been placed in foster care in Clackamas County. CASA stands for Court Appointed Special Advocates, and the organization recruits, trains, and supports community volunteers to become advocates for children who have entered the foster care system.

MISSION

CASA of Clackamas County recruits, trains, and supports court appointed special advocates: community volunteers who advocate for the best interest of children in the foster care system who need safe, permanent homes.

We envision a world where children who experience abuse and neglect are given the opportunity to thrive.

VIV'S STORY

Viv's journey with CASA began around 30 years ago when she became a foster child/ward of the state due to her mother's mental health struggles. Despite the challenging circumstances, Viv never lost her love for her mother. In 1989, her mother had a nervous breakdown, leading to Viv and her brothers being placed in different foster homes. The social workers' belief that "Nobody wants a teenager" further added to the difficulties.

Over the years, Viv experienced numerous foster homes and a group home before finding a guardian at the age of seventeen. Amidst the constant changes and challenges, Gwen Nye, Viv's CASA worker, became a consistent and caring force in her life. Gwen's advocacy in court, genuine concern for Viv's well-being, and consistent presence made a lasting impact. Their close bond included shared adventures, cooking lessons, and even winning a costume contest dressed as Sylvester and Tweety Bird.


Life as a foster kid was tough, and having someone like Gwen to count on meant the world to Viv. She credits Gwen for where she is today and is now eager to give back to CASA. After her son graduated high school, Viv felt a calling to be of service in a role that would be emotionally fulfilling. A chance encounter with a CASA office and a conversation with a foster parent while purchasing a fridge in Salem, OR solidified her decision to become a CASA volunteer in Clackamas County.

Viv sees herself as a foster kid success story, acknowledging the struggles many face. CASA played a crucial role in her life, holding people accountable and providing emotional support. Grateful for the benefits she received as a child, Viv is now proud to be part of CASA, hoping to be for another child what Gwen was for her.

CHILDREN WITH A COURT APPOINTED SPECIAL ADVOCATE (CASA):

- Perform better academically
- Have better behavior in school
- Are more likely to be reunified
- Are 2x as likely to achieve permanency
- Report higher levels of hope
